Stone Fruit, Nut Crops, Citrus & Olives: 1-4 pts per 100 gal near bloom, during the growing season

Vine Crops: 1-4 pts/ 100 gal ahead of, during and shortly following bloom as well as throughout the growing season.

Vegetable & Field Crops, Tropical Fruits and Berries: 1-4 pts per 100 gal applied from 3rd-4th leaf stages throughout the season.

Tropical Fruits: 1-4 pts per 100 gal applied from 3rd-4th leaf stages throughout the season.

Ornamentals: 1/4-2 oz/gal applied throughout the growing season.
