For best results always use **IOTA** in conjunction with **Fusion 360 Soil**.

This material may be sprayed onto the soil, injected into the irrigation water or delivered through shanking.

IOTA may be mixed with most carbon sources, fertilizers or other additives.

DIRECTIONS FOR USE:

Alfalfa: 1/2-1 gpa as a water run with fertilizer and F360 SOIL.

Stone Fruit & Nuts: 1/2-3 gpa mixed with fertilizer and F360 SOIL & either sprayed or dribbled onto the soil or injected into the irrigation water.

Citrus & Olives: 1/2-3 gpa mixed with fertilizer and F360 SOIL and either injected into irrigation, sprayed or dribbled onto the soil.

Vine Crops: 1/2-2 gpa mixed with fertilizers and F360 SOIL through the growing season. **(Note: Apply at lower rates for initial 2 sprays increasing rates thereafter)**

Vegetable & Field Crops and Berries: 1/2-2 gpa mixed with fertilizer and F360 SOIL shanked, sprayed or water run.

Tropical Fruits: 2qt-3gpa applied with fertilizers and F360 SOIL throughout the growing season.

Ornamentals: 1-2 qts/1,000 sqft with F360 soil & fertilizers throughout the growing season.
