**IOTA-O** may be sprayed onto the soil, injected into the irrigation water or delivered through shanking.

**IOTA-O** may be mixed with most carbon sources, fertilizers or other additives but is specifically designed to produce the best results when used with **Fusion 360 Soil-O**. Consult with a field representative for proper rates and possible compatible combinations.

### DIRECTIONS FOR USE:

**Alfalfa:** 1/2-1 gpa as a water run with fertilizer + F360-SOIL-O.

**Stone Fruit & Nuts:** 1/2-2 gpa mixed with fertilizer + F360-SOIL-O & either sprayed or dribbled onto the soil or injected into the irrigation water.

**Citrus, Olives & Tropical Fruits:** 1-3 gpa mixed with fertilizer + F360-SOIL-O either injected into irrigation, sprayed or dribbled onto the soil.

**Vine Crops:** 1/2-2 gpa as for trees.

**Vegetable & Field Crops & Berries:** 1/2-1 gpa mixed with fertilizer + F360-SOIL-O and shanked, sprayed or water run.

**Vegetable Crops:** 1-2 qts/1,000 sqft with F360 Soil -O and fertilizers throughout the growing season.
